ACCOMMODATION	Centria's International Office will book accommodation for incoming exchange students upon request in the application. All student accommodation facilities are located within walking distance from the campus. Accommodation is in shared apartments (2 – 3 students in the same flat, with a private room). The rent varies from 290 to 380 €/month, but payment for all months is done at once before the exchange starts. Students also need to pay a refundable security deposit (350 €).
